Not everyone pays attention to this gap between aspirational values and practiced values. A misalignment can leave us feeling disengaged, unfulfilled, or unmotivated.

So, think of this Annual Report as an organizational self-assessment of sorts. In these pages you will find qualitative and quantitative data (stories and numbers) to support our answer to the question: *Is JFS living our values?*

As you read, we hope you find a connection to the stories, and we hope it’s clear how our values play out in our daily work. ALL PEOPLE ARE WORTHY OF DIGNITY AND RESPECT. WE BELIEVE THAT PEOPLE CAN MAKE POSITIVE CHANGES IN THEIR LIVES, AND WE ARE HERE TO SUPPORT, NON-JUDGMENTALLY, AS THEY MAKE THEIR JOURNEY.

JFS serves 294 low-income Holocaust survivors across Connecticut. Alongside the challenges of aging and loss of independence, survivors carry lifelong trauma rooted in hunger, displacement, and deprivation. Through compassionate programs, from kosher food and meal delivery to home care and case management, JFS helps survivors age with dignity and remain safely at home.

Honoring Lives with Care and Compassion

Established in 2024 at the Jewish Community Foundation of Greater Hartford, the Chameides, Chase, Dodd, Konover/Coppa, Lazowski and Weiner/Temkin Holocaust Dignity Fund helps JFS ease survivors' financial burdens during some of life's hardest moments. The fund covers medical and dental needs, assistive equipment, housing costs, and funeral and burial expenses when needed.



One family member wrote, "I want to extend my heartfelt thanks for your generous support toward the funeral expenses for my father. Your kindness...brought not only financial relief but also a profound sense of comfort and solidarity. It's not just the financial assistance; it's the compassion behind it that touches me most. Thank you for standing with me in this moment."

A Warm Meal, A Little Peace of Mind

Kosher meal deliveries from Care at Home by JFS, our in-home senior care service, are a lifeline for many Holocaust survivors who can no longer shop or cook safely. When Inge and her husband, Leo, were ill and grieving their son, meal deliveries from JFS helped them get through an incredibly difficult time. Ella turned to JFS for help after a hand injury, and she still utilizes our food pantry and meal deliveries today. One family shared, "We heat the meal, and suddenly we have a full dinner. It helps us tremendously."





Integrity

WE DO OUR WORK WITH HONESTY. WE ARE RELIABLE AND ACCOUNTABLE STEWARDS OF THE ORGANIZATION.

At JFS, integrity is at the core of everything we do. Our mental health clinicians are a great example. Integrity in mental health care means protecting client privacy, adhering to evidence-based standards, and participating in continuing education. Integrity means showing up consistently, even when the work is difficult, and ensuring culturally responsive, affirming care. It also means practicing what we teach: self-reflection, accountability, and growth. By modeling integrity, our clinicians help clients become more aligned with their own core values and improve their quality of life.

Making SPACE for Anxious Children to Grow

When Erin Reynolds (not her real name) realized her 9-year-old daughter's anxiety was shaping daily life from bedtime to birthday parties, she knew something had to change. Small accommodations meant to soothe anxiety had become barriers to independence.



Through JFS, Reynolds enrolled in the SPACE (Supportive Parenting for Anxious Childhood Emotions) program. Rather than focusing solely on the child, SPACE helps parents adjust their own responses, building children's confidence and self-regulation.

With guidance, Reynolds learned how to be supportive without reinforcing anxiety. Over time, her daughter gained tools to manage anxiety independently. JFS offers SPACE in group and individual formats, helping families grow stronger, one steady step at a time.



Finding Connection Through Grief

"Grief never fully disappears, but sharing it makes it more bearable," says Theodora "Teddy" Sirota, a psychiatric APRN with a PhD in nursing research. As the lead facilitator of JFS's free bereavement support group for adults, Dr. Sirota brings both professional expertise and personal experience: she lost her husband more than nine years ago.

The group meets weekly, and it is open-ended; participants may attend as often and as long as they want. In a compassionate, structured space, they share stories, learn coping strategies, and find reassurance that they are not alone.

JFS is community-centric and community-based. We adapt our services to meet local needs. We walk alongside people of all ages, backgrounds, and circumstances as they work toward their goals. And we rely on your generous contributions of time, skills, and financial and other resources. In fiscal year 2025, JFS was especially blessed by the 350 volunteers who gave 2,100 hours to help our clients improve their lives.

Volunteers at the Anja Rosenberg Kosher Food Pantry distributed 600 pounds of spices and 6,500 bags of food to families in need, and they helped clients celebrate the holidays with 200 Passover bags and 400 Thanksgiving meals. JFS volunteers also spent over 200 hours coaching clients on nutrition, finances, and other vital topics. They did it all with dignity, warmth, and compassion. We celebrate our volunteers with a festive reception each spring—but in truth, we give thanks for their generous spirit every single day.

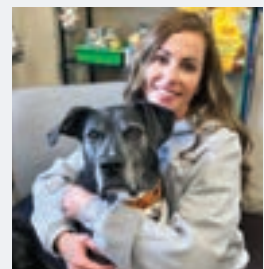

Pets are an essential source of comfort, stability, and emotional support, especially during times of stress. Odie's Shelf—part of the Anja Rosenberg Kosher Food Pantry at JFS—ensures that no one in our community has to choose between feeding themselves and feeding their pets. Founded by Maddie Rosenberg Toro as her bat mitzvah project, Odie's Shelf has become a family project, and Maddie's cousin Sarah Rosenberg, shown here, is a steadfast contributor. Odie's Shelf is named for Sarah's late dog, Odie, who had a profound impact on her life and passion for helping animals in need.





Fairness

IT IS OUR RESPONSIBILITY TO ENABLE EQUITABLE ACCESS, SO THAT ALL CLIENTS HAVE AN EQUAL OPPORTUNITY TO ACHIEVE STABILITY IN THEIR LIVES.

Comprehensive Community Supports (CCS) at JFS helps individuals and families level the playing field and move toward lasting financial security. CCS offers one-on-one support with a certified financial social worker. Clients create a personal budget, set financial goals, learn about resources to help with bills, and develop positive financial habits.

JFS also enlists professional and volunteer specialists to help CCS clients achieve self-sufficiency, including CERTIFIED FINANCIAL PLANNER™ Jim Goldman; the Jewish Free Loan Fund of Greater Hartford; pro bono attorneys; and others.

Growing Skills, Savings, and Resilience

When Rebecca (name changed) came to JFS after leaving a financially abusive marriage, even checking her bank account felt overwhelming. With guidance from CCS Client Support Specialist Alicia Hernandez, Rebecca built the confidence and skills to take control of her finances. Together they set realistic goals, created a budget, and connected her with free tax preparation and short-term food support. As Rebecca's confidence grew, she saved \$250 a month, negotiated a 5% raise, and opened a high-yield savings account. Alongside financial coaching and therapy, she built six months of emergency savings, sent her son to summer camp, and referred her new partner to CCS.



Bridging the Gap

CCS helps families bridge the gap between getting by and moving forward. Recently, we helped a young mother purchase public school uniforms for her children. "Thank you so much," she shared. "You have no idea how much stress this took off me. Truly, you are a blessing."

JFS Named West Hartford Chamber's Nonprofit of the Year

JFS was honored and humbled to receive the Nonprofit of the Year Award from the West Hartford Chamber of Commerce on June 24, 2025. "JFS has been a keystone in the region for over a century," said Chamber President and CEO Chris Conway.

JFS Professionals Recognized for Work with Russian Speakers, Holocaust Survivors

JFS teammates Svetlana Berlinsky and Lucy Dratva received the 2025 Henry M. Zachs Spirit of Judaism Award, honoring their extraordinary service to Russian-speaking community members and Holocaust survivors. The award was presented at the Jewish Federation of Greater Hartford's Annual Meeting in September. Berlinsky is a licensed clinical social worker at JFS; Dratva works with JFS as an interpreter and also coordinates the Mandell JCC's New Americans program.





JFS Programs

EVERYONE DESERVES THE TOOLS FOR A STABLE AND HEALTHY LIFE. JFS PROVIDES A RANGE OF RESOURCES FOR PEOPLE OF ALL AGES AND BACKGROUNDS.

The **ANJA ROSENBERG KOSHER FOOD PANTRY** provides food to anyone in need. It offers fresh produce, eggs, pantry staples, and spices as well as paper goods, diapers, and pet food. A volunteer nutrition counselor is available by appointment.

MENTAL HEALTH SERVICES are available for people of all ages. JFS offers individual, couple, and family counseling with licensed clinicians, as well as psychiatric care.

YOUTH MENTAL HEALTH PROGRAMS offer information, tools, and support that help young people and those who care about them proactively address mental health.

HOLOCAUST SURVIVORS PROGRAM provides emergency assistance to very-low-income Holocaust survivors and ensures they have the basics for a stable, healthy life.

RUSSIAN-SPEAKING OLDER ADULTS, refugees and Holocaust survivors from the Former Soviet Union get help with translation, navigating social services and medical bills, and accessing benefits and nutritious food.

TECHNOLOGY SUPPORTS FOR OLDER ADULTS include Uniper, a TV-based technology that reduces isolation, and Memory Lane TV, which assists seniors with memory loss.

VICTIMS OF CRIME ACT (VOCA) CASE MANAGEMENT helps survivors of crime navigate the court system, find the resources they need, and begin healing.

TEMPORARY ASSISTANCE FOR NEEDY FAMILIES* (TANF, formerly Welfare to Work) Case Management helps clients develop life goals, build income, and avoid eviction and utility shutoffs.

CARE AT HOME BY JFS provides hourly and 24/7 live-in care, personal care assistance, friendly companionship, and kosher meal delivery to help local seniors live independently. Care at Home covers its own operating costs and supports a variety of free and subsidized JFS services.

COMPREHENSIVE COMMUNITY SUPPORTS helps individuals and families move toward financial stability with holistic case management, financial education, and more.

MONEY COACH is a volunteer CERTIFIED FINANCIAL PLANNER™ who provides expert, one-on-one advice to help clients pay down debt and save for the future.

JFS works with local partners and volunteers to assist **REFUGEES** as they build new lives in Greater Hartford.
